Dr. Heidenreich replied by stating that there is a Math curriculum set out by the State. Unfortunately, the roll out of this program was not implemented in a timely manner where books and modules were not in alignment. Greg Guercio, Attorney for the District shared that Board cannot take a "stand" to the public, only to the associations that they belong to.
