New BusinessSuperintendent of Schools**A. Approval of District Budget - 2015-16**

Be it resolved that the Board of Education, upon the recommendation of the Superintendent of Schools, approve the proposed school district budget for the 2015-16 school year in the amount of \$109,702,140.

Superintendent Heidenreich shared with the Board that this budget has a tax levy of 2.13% with no reductions and that the District would be restoring, as well as adding, some important attributes for our students. Dr. Heidenreich recommended that the Board approve this budget.

A parent asked what were some of these attributes to which Dr. Heidenreich explained that:

Guidance counselors, teacher assistants and social workers would be added to the schools.  
Maintenance staff as well as a permanent position to Special Ed would be added.  
The District would be adding 3 clubs per school and  
An air rifle team would be reestablished.

Capital improvements to various District school buildings substantially as described in the summary report developed by the District completed on January 10, 2015 (the "Summary"), which is on file and available for public inspection at the office of the District Clerk, such improvements consisting of restroom renovations, fire safety upgrades, rooftop exhaust fan replacements, exterior door replacements, ADA compliance upgrades, roofing and roof ladder repairs and replacements, installation of carbon monoxide detection and the installation of an emergency communication system; the foregoing to include the original equipment, machinery, apparatus and ancillary or related work required in connection therewith, provided the detailed costs of the components of the Capital improvements as set forth in the Summary may be reallocated among such components if the Board of Education shall determine that such reallocation is in the best interest of the District.

3. 6NYCRR617.5 {c} (8); Routine activities of educational institutions, including expansion of existing facilities by less than 10,000 square feet of gross floor area and school closings, but not changes in use related to such closings.

Therefore, as the lead agency for the SEQRA determination, all the above referenced projects fall under Categories "A" or "B" above. The procedure for Type II Actions, with regard to the SEQRA Process for Capital Projects noted above is "No Additional Required Action under 6NYCRR/617.5 {a}".
