## Information and Exploration

### 1. Summer School 2016 Report

Dr. Troisi stated that the summer school program commenced on August 19th with 11 graduates and thanked the Board members that attended the commencement ceremony. Dr. Troisi also stated that the 4 day program, which

was new to the district this year, was very well accepted. Each Board member that attended the graduation ceremony felt that it is a wonderful practice to honor the students for their continued commitment to receive their diplomas.

## 3. Proposed Bond Issue

Dr. Heidenreich stated that as was previously discussed in our July meeting, the Bond issue is still moving forward with work being considered on roofs, restrooms, enhancing science classrooms and three astroturf fields for the buildings. Dr. Loper discussed the cost to taxpayers if such Bond would go through: District 13 would have a \$52.96 per year increase, District 24 would have a \$46.17 per year increase and District 30 would have a \$37.56 per year increase. It was asked by a Board member to investigate the costs of having such a vote.

Dr. Heidehreich shared that he would like further discussion about the Bond at next week's meeting; in order to move forward with a December 2016 vote date there would be a lot of work needed to educate the public.
